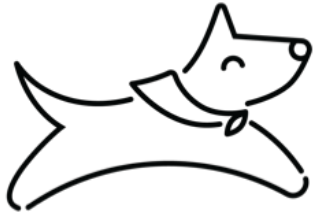

| • Handlers, Instructors and Assistants <b>must</b> wear a face covering while on the property of the Dog Training Center and for the duration of the indoor class.   | _____          |
| • In order to provide as safe an environment as possible for everyone, please limit who attends class with your dog. One handler per dog is strongly preferred, with a maximum of two handlers per dog if they are from the same household. NO CHILDREN will be permitted in the building until further notice. All handlers participating in training must sign a separate COVID 19 and Indoor Training Protocol waiver.  | _____          |
| • You may be asked to undergo a temperature check upon entering the building. Those with a temperature over 100 degrees will be asked to not participate in class and leave the building that day.   | _____          |
| • Upon entering the building, you must sanitize your hands with sanitizer available in the lobby. There will additionally be hand sanitizer in each training room for you to use at your comfort or whenever you are to touch an item that is not your own.  | _____          |
| • Maintain a 6' minimum distance between yourself and your dog from any others while on the grounds of the Dog Training Center. This includes yourself, your dog, and any other dogs/handlers  | _____          |
| • If you are at a training station during class, you are to wipe the chair down with a sanitizing wipe (available at each station) before and after class. This applies to all basics level classes and any others where chair use is required.  | _____          |
| • You are expected to bring to class every item you normally would including a leash, treat pouch, and ample treats for the duration of class. Additionally, we ask that you bring: <ul style="list-style-type: none"> <li>• Water and a water bowl for your dog during their time at the Dog Training Center.</li> <li>• It is advised to bring your own hand sanitizer with you to class. The club will additionally have multiple bottles on hand for group use.</li> </ul> | _____          |
| • Be aware that bathroom use is limited at this time to one person. After washing your hands please spray down the toilet flush handles, stall door handles and sink handles with provided disinfectant spray.   | _____          |



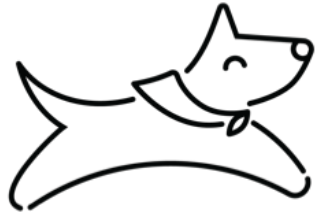

Dog Training Center of Chester County Covid-19 Waiver (to be signed by all handlers)

I agree to follow The Dog Training Center's guidelines, precautions and requirements to mitigate the possibility of The Dog Training Center of Chester County's Class Attendees, Instructors, Instructors' Assistants, or Volunteers contracting or spreading COVID-19. The Dog Training Center of Chester County reserves the right to refuse service to anyone disregarding the guidelines, and no refunds will be given in such a case.

I understand the risks of contracting or being exposed to COVID-19 associated with my attendance, and I knowingly accept those risks.
