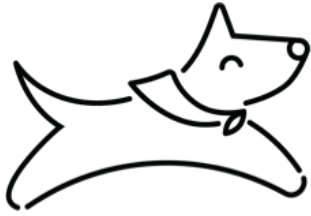
Dog Training Center of Chester County Indoor Safety Protocol (to be signed by all handlers)

Bring your signed waiver and Indoor Safety Protocol with you on the first day of class, there will be a folder for you to place them in. Please initial each section as well as sign and date the end

Please Initial

- To respect the varied needs and comfort levels of our instructors and students, we continue to encourage masking. Please come to the center prepared to wear a mask indoors; however, you may follow the lead of your instructor. If they remove their mask in the classroom, you are welcome to do the same. We would greatly appreciate those who are not vaccinated to keep their masks in place (this includes children). _____
- In order to provide as safe an environment as possible for everyone, please limit who attends class with your dog. One handler per dog is strongly preferred, with a maximum of two handlers per dog if they are from the same household. All handlers participating in training must sign a separate COVID 19 and Indoor Training Protocol waiver. _____
- You may be asked to undergo a temperature check upon entering the building. Those with a temperature over 100 degrees will be asked to not participate in class and leave the building that day. _____
- Upon entering the building, you must sanitize your hands with sanitizer available in the lobby. There will additionally be hand sanitizer in each training room for you to use at your comfort or whenever you are to touch an item that is not your own. _____
- Maintain a 6' minimum distance between yourself and your dog from any others while on the grounds of the Dog Training Center. This includes yourself, your dog, and any other dogs/handlers _____
- You are expected to bring to class every item you normally would including a leash, treat pouch, and ample treats for the duration of class. Additionally, we ask that you bring:
 - Water and a water bowl for your dog during their time at the Dog Training Center.
 - It is advised to bring your own hand sanitizer with you to class. The club will additionally have multiple bottles on hand for group use.

- Be aware that bathroom use is limited at this time to one person. After washing your hands, please spray down the toilet flush handles, stall doorhandles and sink handles with provided disinfectant spray. _____

- If you are in a class where crating is required, please bring your own crate, no club owned crates are to be used. Crating areas will be outlined to you by the instructor. This does not apply to basics classes. _____
- Ample hand sanitizers and wipes are available at the club, please aid us in keeping everyone safe by wiping down any areas you touch while at the Dog Training Center. _____
- Use of the bathrooms, cleaning of them, and hand sanitizer use while at the Dog Training Center is under the Honor system, anyone observed not to be following the protocol will be asked to leave the building and/or will be removed from the class roster going forward. _____

Dog Training Center of Chester County Covid-19 Waiver (to be signed by all handlers)
